IMPORTS AND EXPORTS (NOVEMBER 2024)**

Electric Reliability Council of Texas, Inc. (ERCOT) submits this Report on DC Tie Energy Imports and Exports pursuant to 16 Tex. Admin. Code (TAC) § 25.192(e)(4), which requires ERCOT to file a public report containing certain information regarding energy imported and exported across DC Ties. Attached hereto as **Exhibit A** is a spreadsheet containing the DC Tie information required by the rule.<sup>1</sup>
