**ERCOT'S REPORT CONCERNING COMPLIANCE WITH WINTER
WEATHER PREPAREDNESS DECLARATION REQUIREMENTS**

In accordance with subsections (c)(4) and (f)(4) of Public Utility Commission of Texas (Commission) Rule 25.55 (16 Texas Administrative Code (TAC) § 25.55), ERCOT submits this report regarding generation entity and transmission service provider (TSP) compliance with the requirement to submit a declaration of winter weather preparedness in 16 TAC § 25.55(c)(3)(A) and (f)(3)(A). As required by subsections (c)(4) and (f)(4), this report indicates whether each entity: (i) timely submitted a declaration, (ii) submitted a declaration late, or (iii) failed to submit a declaration as of 17:00 on December 17, 2024.

Subsections (c)(3)(A) and (f)(3)(A) of 16 TAC § 25.55 require entities to submit a declaration of winter weather preparedness to ERCOT by the first of December each year. The declaration must include a summary of activities performed to comply with the winter weather preparation measures in 16 TAC § 25.55(c)(1) and (f)(1) and a notarized attestation confirming completion of the activities required by the rule. *See*, 16 TAC § 25.55(c)(3)(A)(v), (f)(3)(A)(v).

On November 1, 2024, ERCOT sent a Market Notice informing Market Participants of the need to submit winter weather declarations.¹ ERCOT required entities to submit declarations to ERCOT via ERCOT's Weatherization and Inspection Market Participant Portal.

In Attachment 1 to this filing, ERCOT indicates whether each entity submitted the declaration late - *i.e.*, whether ERCOT received it after the December 1, 2024 deadline or failed to submit the declaration as of 17:00 on December 17, 2024. ERCOT has not yet verified the quality of submissions (but intends to do so).

As shown in Attachment 1, most entities timely submitted declarations. Out of 528 total generation entities, ERCOT received completed declarations from 519 (98.3%) by the December 1, 2024 deadline. No generation entity declarations remain outstanding.

Of 57 total TSPs submitting declarations, 54 (94.7%) submitted declarations by the

December 1, 2024 deadline. No TSP declarations remain outstanding.

ERCOT will provide the Commission any additional information it may need to evaluate the information in this report.
