Dear Mr. Burch:

On behalf of the owner of Faudree Ranch Apartments, Faudree Ranch Apartments Odessa, LLC, we would like to request a change in the billing methodology at the above referenced community from a sub metered method to a RUBS allocated billing method.

The current sub metering system consists of a water sub meter installed in each apartment along with an attached radio frequency transmitter. The RF meter reading system has proven to be very unreliable and has become more costly to maintain over time. We are recommending a system upgrade and the estimated cost to replace this system, and a % of the meters, is more than \$30,000.00. Please find quote included in this filing.

We are requesting that this property be allowed to change to an Allocated Billing method. The community understands the process of changing to this method including residents signing a new lease or a lease addendum and providing the residents 35 days notification prior to implementing the new billing method. Please review this letter and let us know how to best proceed.
