COMMISSION STAFF'S INITIAL LIST OF POLRS AND VREPS

I. INTRODUCTION

The Public Utility Commission of Texas (Commission) initiated this proceeding pursuant to PURA § 39.106 and 16 Texas Administrative Code (TAC) § 25.43 to designate providers of last resort (POLR) service for the 2025-2026 term. The rule applies to all retail electric providers (REPs) that are serving retail customers in transmission and distribution utility (TDU) service areas and requires that all REPs provide information to the Commission necessary to establish their eligibility to serve as a POLR for the next term. The following two types of POLR providers are described in 16 TAC § 25.43: voluntary retail electric providers (VREPs) and large service providers (LSPs).

On April 4, 2024, the administrative law judge (ALJ) filed Order No. 1, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file an initial proposed list of LSPs eligible to serve as a POLR, LSP affiliates approved to serve as a POLR, and VREPs by August 30, 2024. Therefore, this pleading is timely filed.

II. INITIAL LIST

Staff provides herein an initial list of POLRs and VREPs for consideration. The memorandum of Kenneth Ford of the Consumer Protection Division is attached, which includes the preliminary list as Attachment 1 and Requests for Designation of Affiliates as Attachment 2 to the memorandum.

Pursuant to 16 TAC § 25.43(h)(3) and (i)(3), Retail Electric Providers (REP) may file challenges to Staff's eligibility determination for an LSP to serve as a POLR, an LSP's affiliate to serve as a POLR, and approved VREPs by September 6, 2024. Such challenges should include additional documentation with the specific data, calculation, and explanation illustrating and

proving the REP's assertion.¹ Challenges to VREP eligibility should include additional evidence of the REPs capability to serve as a VREP.²

Staff will file a recommendation on final disposition on September 18, 2024, both responding to any challenges filed and including a final list of LSPs eligible to serve as POLRs, LSP affiliates approved to serve as POLRs, and approved VREPs. Staff will also file a proposed order on September 19, 2024.

Preliminary List of POLR Providers and VREPs

Under 16 Texas Administrative Code (TAC) § 25.43, by October 15 of each evennumbered year, the Commission must select retail electric providers (REPs) that will provide provider of last resort (POLR) service for a two-year term beginning in January of each oddnumbered year. This selection process is provided for areas of the state in which customer choice is in effect in the service areas of the transmission and distribution utilities (TDUs): Oncor Electric Delivery Company (Oncor), CenterPoint Energy Houston Electric LLC (CenterPoint), Texas-New Mexico Power Company (TNMP), and AEP Texas- divided into the former service areas of AEP Texas North Company (AEP North) and AEP Texas Central Company (AEP Central). Eligibility to serve as a POLR is determined according to the process described in 16 TAC § 25.43(g) - (j) that identifies REPs that are eligible to be designated to provide POLR service in designated service areas and voluntary retail electric providers (VREPs), i.e. those REPs that have volunteered to provide POLR service within a specific service area for a specific class of service.

On April 4, 2024, Order No. 1, *Establishing Procedural Schedule* was filed by the administrative law judge (ALJ). Order No. 1 required REPs to file information to establish eligibility to serve as a POLR, and provided that any REP designated as a large service provider (LSP) POLR may request that an affiliate provide POLR service on behalf of the designated REP. Order No. 1 also required REPs to file, by July 31, 2024, any requests if the REP wanted to be considered for eligibility to be designated as a VREP to provide POLR service. Only one REP had filed a request to be designated as a VREP, TXU Energy Retail Company LLC (REP No. 10004).

As a result of the preliminary analysis, Staff has included the following attachments: (1) Attachment 1 identifies those companies that are eligible to be designated to provide POLR

service to four specific classes of service (Residential, Small Non-Residential, Medium Non-Residential and Large Non-Residential) within five service territories identified above and identifies any REPs that have volunteered to be a POLR within a specific service area for a specific class of service; and (2) Attachment 2 identifies individual REPs designated as an LSP POLR that have requested that an affiliate provide POLR service on behalf of the designated REP. These preliminary findings will be posted to the Commission's website created for this project on August 30, 2024.

Under 16 TAC § 25.43(h)(3) and (i)(3), REPs may challenge their eligibility to be designated as a POLR or VREP within five business days of this notice of eligibility by submitting in this project documentation, calculations and a specific explanation that clearly illustrates and supports the REP's assertion. Staff will accept the challenges and clarifications through Friday, September 6, 2024.

After Staff has investigated any challenges, Staff will designate up to 15 REPs from the eligible list to serve as LSP POLRs for the 2025-2026 term. The final list of designated LSP POLRs and final list of VREPs will be posted to the Commission's website created for this project by September 18, 2024. On July 7, 2016, the Commission issued an order in Project No. 43518 granting Commission Staff's request to delegate authority to Docket Management to approve the final list of REPs that are designated as POLRs in each even-numbered year.

Requests for Designation of Affiliates

Under 16 Texas Administrative Code (TAC) § 25.43(k), an LSP may request that the Commission designate an LSP affiliate to provide POLR service on behalf of the LSP either with the LSP's filing in this project or as a separate item in the current term project under 16 TAC §§ 25.43(h) and (k). Several REPs requested that the Commission designate an affiliate to provide POLR service on their behalf should the REP be designated as an LSP. The REPs listed below made this request:

Fulcrum Retail Energy, LLC (REP Certificate 10081) (Fulcrum Retail)

Fulcrum Retail requested that if it is designated as an LSP for the Residential customer class in any TDU service area for the 2025-2026 term, that the Commission designate their affiliate Just Energy Texas (REP Certificate No. 10052) (Just Energy) to provide POLR service on their behalf. Just Energy agreed to provide POLR service on behalf of Fulcrum Retail for the requested customer class for the 2025-2026 term.

Fulcrum Retail also requested that if it is designated as an LSP for the Small Non-Residential, Medium Non-Residential, or Large Non-residential customer classes in any TDU service area for the 2025-2026 term that the Commission designate their affiliate Hudson Energy Services LLC (REP Certificate No 10092) (Hudson Energy) to provide POLR service on their behalf. Hudson Energy agreed to provide POLR service on behalf of Fulcrum Retail for the requested customer classes in the requested TDU service areas for the 2025-2026 term.

Based upon Staff's review of Fulcrum Retail's requests, Staff has determined that Just Energy and Hudson Energy meet the eligibility requirements of 16 TAC § 25.43(k) to provide POLR service on behalf of Fulcrum Retail for the requested customer classes in the requested TDU service areas.

Hudson Energy Services LLC (REP Certificate No 10092)

Hudson Energy requested that if they are designated as an LSP for the Residential customer class in any TDU service area for the 2025-2026 term, that the Commission designate their affiliate Just Energy to provide POLR service on their behalf. Just Energy agreed to provide POLR service on behalf of Hudson Energy for the requested customer class for the 2025-2026 term.

Based upon Staff's review of Hudson Energy's request, Staff has determined that Just Energy meets the eligibility requirements of 16 TAC § 25.43(k) to provide POLR service on behalf of Hudson Energy for the Residential customer class in all TDU service areas.

Just Energy Texas (REP Certificate No. 10052)

Just Energy requested that if it is designated as an LSP for the Small Non-Residential, Medium Non-Residential or Large Non-Residential customer classes in any TDU service area for the 2025-2026 term, that the Commission designate its affiliate Hudson Energy to provide POLR service on its behalf. Hudson Energy agreed to provide POLR service on behalf of Just Energy for the requested customer classes in the requested TDU service areas for the 2025-2026 term. Based upon Staff's review of Just Energy's request, Staff has determined that Hudson Energy meets the eligibility requirements of 16 TAC § 25.43(k) to provide POLR service on behalf of Just Energy for the requested customer classes in all TDU service areas.

Tara Energy, LLC (REP Certificate 10051) (Tara Energy)

Tara Energy requested that if it is designated as an LSP for the Residential customer class in any TDU service area for the 2025-2026 term, that the Commission designate their affiliate Just Energy to provide POLR service on their behalf. Just Energy agreed to provide POLR service on behalf of Tara Energy for the requested customer classes in the requested TDU service areas for the 2025-2026 term.

Tara Energy also requested that if it is designated as an LSP for the Small Non-Residential, Medium Non-Residential or Large Non-Residential customer classes in any TDU service area for the 2025-2026 term that the Commission designate their affiliate Hudson Energy to provide POLR service on their behalf. Hudson Energy agreed to provide POLR service on behalf of Tara Energy for the requested customer classes in the requested TDU service areas for the 2025-2026 term.

Based upon Staff's review of Tara Energy's requests, Staff has determined Just Energy and Hudson Energy meet the eligibility requirements of 16 TAC § 25.43(k) to provide POLR service on behalf of Tara Energy for the requested customer classes in the requested TDU service areas.

Reliant Energy Retail Services (REP Certificate No. 10007) (Reliant Energy), Direct Energy Business, LLC (REP Certificate No. 10011) (Direct Energy Business), Direct Energy LP, (REP Certificate No. 10040) (Direct Energy), Green Mountain Energy Company (REP Certificate 10009) (Green Mountain), NRG Controllable Load Services LLC (REP Certificate 10311) (NRG Controllable Load), Stream SPE Ltd. (REP Certificate 10104) (Stream); US Retailers LLC (REP Certificate 10177) (US Retailers), and XOOM Energy Texas, LLC (REP Certificate 10203) (XOOM Energy).

Direct Energy Business, Direct Energy, Green Mountain, NRG Controllable Load, Stream, US Retailers, and XOOM Energy, all of which are subsidiaries of NRG Energy Inc., requested that if they are designated as an LSP for any customer class in any TDU service area for the 2025-2026 term, that the Commission designate their affiliate Reliant Energy to provide POLR service on their behalf. Reliant Energy agreed to provide POLR service on behalf of these affiliates for the requested customer classes in the requested TDU service areas for the 2025-2026 term.

Based upon Staff's review of the requests by the affiliates, Staff has determined that Reliant Energy meets the eligibility requirements of 16 TAC § 25.43(k) to provide POLR service on behalf of Direct Energy Business, Direct Energy, Green Mountain, NRG Controllable Load, Stream, US Retailers, and XOOM Energy for all customer classes in all TDU service areas.

Ambit Texas, LLC (REP Certificate No. 10117) (Ambit), Value Based Brands LLC (REP Certificate No.10041) (Value Based Brands), TriEagle Energy LP (REP Certificate No.10064) (TriEagle)

Ambit, Value Based Brands, and TriEagle Energy, all of which are subsidiaries of Vistra Corp., requested that if any of them are designated as an LSP for any customer class in any TDU service area for the 2025-2026 term, that the Commission designate their affiliate TXU Energy to provide POLR service on their behalf. TXU Energy agreed to provide POLR service on behalf of these affiliates for the requested customer classes in the requested TDU service areas for the 2025-2026 term.

Based upon Staff's review of the requests by these affiliates, Staff has determined that TXU Energy meets the eligibility requirements of 16 TAC § 25.43(k) to provide POLR service on behalf of Ambit, Value Based Brands, and TriEagle Energy for all customer classes in all TDU service areas.
