# COMMISSION STAFF'S REQUEST FOR EXTENSION

### I. INTRODUCTION

On January 17, 2024, Stonetown Windfern Utilities, LLC (Stonetown Windfern) filed an application for a class D rate adjustment for certificate of convenience and necessity (CCN) numbers 13307 and 21135. The application indicates there are 92 active water and sewer connections. Stonetown Windfern filed supplemental information on February 2, 2024, and March 11, 2024.

On March 14, 2024, the administrative law judge (ALJ) filed Order No. 5, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a clarification regarding the proposed notice attached to Staff's March 13, 2024 filing by March 14, 2024. Therefore, this pleading is timely filed.

# II. REQUEST FOR EXTENSION OF TIME

Under 16 Texas Administrative Code § 22.4(b), a party may request that the time allowed for filing any documents be extended for good cause. Staff needs additional time to confer with applicant before makings its recommendation. Therefore, Staff respectfully requests an extension of time until March 21, 2024, to file a clarification regarding the proposed notice attached to Staff's March 13, 2024 filing.
