Question No. TIEC 3-2:

Referring to page 23, Figure 3:

- a. Please expand Figure 3 to include calendar years 2019 and 2023. If you object to providing an expanded figure, please provide all data necessary to expand the figure to include calendar years 2019 and 2023.
- b. Please confirm that Figure 3 includes only transmission-related expenses. if not confirmed, please separate the annual vegetation management expenses between transmission and distribution for the period 2019 through 2023.

The Company notes that the information provided in Figure 3 of Company Witness Robinson's direct testimony, and the corresponding workpaper, was incorrect. The company revises this information with the preceding chart. These amounts represent vegetation management expenditures recorded in FERC Account 571 (transmission) for the indicated periods.

- b. The Company confirms that the chart provided in response to TIEC 3-2(a) includes only vegetation management expenditures recorded in FERC Account 571 (transmission).

Supplemental Response No. TIEC 3-2:

The original response to TIEC 3-2 provided only vegetation management expenses charged to FERC Account 571. However, there are also vegetation management expenses booked to FERC Account 570. Please refer to TIEC 3-2 Supplemental Attachment 1 which reflects all Transmission vegetation management expenditures during 2019- 2023, including the test year.

There is no change to the amount for vegetation management in the Test Year Cost of Service.
