TIMOTHY S. LARGE'S MOTION TO INTERVENE

Pursuant to the PUBLIC UTILITY REGULATORY ACT ("PURA"), TEX. UTIL. CODE §§1.001 et seq., and §§ 22.102, 22.103(b), and 22.104 of the Procedural Rules of the Public Utilities Commission of Texas ("Commission"), Timothy S. Large, ("Timothy") submits this Motion to Intervene and respectfully requests an order permitting his intervention and participation in this proceeding. In support of this motion, Timothy states as follows:

1) On March 6, 2024, CenterPoint Energy Houston Electric, LLC ("CenterPoint") filed its application ("Application") for the authority to change rates. Timothy seeks to participate in this proceeding to ensure that CenterPoint's rates are just and reasonable.

2) Timothy is the property owner within CenterPoint's service area in Montgomery County, which land is subject to CenterPoint's existing Certificate of Convenience and Necessity granting authority to furnish electricity to landowners, tenants, and other customers within its authorized service area. Proposed changes in electrical rates may therefore impact Timothy during the period such proposed rates are established and remain in effect. Accordingly, Timothy has a justiciable interest in this proceeding.

3) Timothy desires to fully participate in this proceeding. Timothy may present evidence on issues in this proceeding as is appropriate to assure that his interests as to reliability, pricing, efficiency, and adequacy of resources, as well as any other appropriate considerations, are

addressed and protected in conjunction with service offered by CenterPoint. William reserves the right to participate in this proceeding as his interest continues to develop throughout the course of this proceeding.
