COMES NOW, the Gulf Coast Coalition of Cities (GCCC) and files this Motion to Intervene as a party to this proceeding. In support of its Motion, GCCC shows as follows:

1. GCCC is made up of municipalities located within the service territory of CenterPoint Energy Houston Electric, LLC (CenterPoint). A list of the GCCC cities is included as Attachment A.

2. On March 6, 2024, CenterPoint filed an application for authority to change rates. GCCC's members as well as their residents and businesses may be adversely impacted by CenterPoint's request. Therefore, GCCC has a justiciable interest in this proceeding.

3. Additionally, GCCC has standing pursuant to Public Utility Regulatory Act (PURA) § 33.025.¹




