**AFFIDAVIT OF ALFRED R. HERRERA RELATED TO RATE CASE EXPENSES
INCURRED BY THE TEXAS COAST UTILITIES COALITION OF CITIES**

Before me, the undersigned authority, on this day personally appeared Alfred R. Herrera, being by me first duly sworn on oath deposed and said the following:

1. My name is Alfred R. Herrera, and I am over 18 years of age and I am not disqualified from making this affidavit. My statements are true and correct.
2. I am the principal and founder of Herrera Law & Associates, PLLC ("HLA"). I have focused my legal career in the public-utility arena and have over 40 years of experience in legal and legislative matters related to the utility industry (gas, electric, water, wastewater, and telecommunications) and have held positions at the Public Utility Commission of Texas ("PUCT"), the City Attorney's Office for the City of Austin, and for a major telecommunications corporation.
3. I am a charter member of the initial class of attorneys to have been board certified by the Texas Board of Legal Specialization in Administrative Law in 1989 and serve on the Administrative Law Advisory Commission for the Texas Board of Legal Specialization, which serves to identify applicants eligible to sit for the Administrative Law specialization exam. I am also a member of the Texas Bar College, a professional society of legal scholars who are leaders in the Texas legal community and champions of legal education. I am a member of the State Bar of Texas; the Public Utility Law Section of the State Bar; and of the Austin Bar Association.
4. I have litigated numerous utility-related rate matters in the electric, telecommunications, gas, and water/wastewater industries having served as lead counsel well in excess of two hundred contested proceedings before the Public Utility Commission of Texas and the Railroad Commission of Texas. I have handled numerous appeals to the Texas Courts of Appeals and the Texas Supreme Court. I obtained a B.A. in American History from the George Washington University and a Doctor of Jurisprudence degree from the University of Texas School of Law. I am a frequent speaker on issues related to municipal law and

electric, water/wastewater, telecommunications, and gas-utility law in continuing legal education courses sanctioned by the State Bar of Texas.

5. My prior experience further informs my perspective having worked in state government (the Public Utility Commission of Texas), served as an assistant city attorney focused on advising a municipally-owned utility (the City of Austin), served as lead regulatory counsel for a major telecommunications interest with responsibility for a five-state region comprised of the States of Missouri, Oklahoma, Kansas, Arkansas, and Texas, and finally, in private practice at Herrera Law & Associates, PLLC (the successor to Herrera & Boyle, PLLC).
6. Further, given my experience and qualifications, I am qualified to render admissible opinions on the reasonableness of TCUC's attorney fees to meet TCUC's evidentiary burden under 16 Texas Administrative Code § 23.245 and Public Utility Regulatory Act ("PURA") § 33.023(b), which provides that the electric utility in a ratemaking proceeding shall reimburse the reasonable costs of services for municipal participation in rate cases.
7. The Texas Coast Utilities Coalition of cities ("TCUC") retained Herrera Law & Associates in connection with the following proceedings, which I collectively refer to as the "*Ratemaking Proceedings*":
 - a. *PUC Docket No. 56211 – Application of CenterPoint Energy Houston Electric, LLC for Authority to Change Rates*;
 - b. *PUC Docket No. 53442 – Application of CenterPoint Energy Houston Electric, LLC for Approval to Amend Its Distribution Cost Recovery Factor*;
 - c. *PUC Docket No. 54825 – Application of CenterPoint Energy Houston Electric, LLC for Approval to Amend Its Distribution Cost Recovery Factor*;
 - d. *PUC Docket No. 54830 – Application of CenterPoint Energy Houston Electric, LLC for Approval to Amend Its Temporary Emergency Electric Energy Facilities Rider*;
 - e. *PUC Docket No. 55993 – Application of CenterPoint Energy Houston Electric, LLC for Approval to Amend Its Distribution Cost Recovery Factor*;
8. The firm of Herrera Law & Associates, PLLC provided services to TCUC in the *Ratemaking Proceedings* including, but not limited to, the following activities: the provision of legal advice and strategy; negotiating schedules and substantive issues; identification of consultants and recommendations to TCUC regarding engagement of consultants; coordination of issue development; legal research; preparation and filing of pleadings, briefs, discovery, and pre-filed testimony; preparation for and participating in

prehearing conferences, preparation for hearings on the merits, and Open Meetings; and briefing clients and discussions with consultants.

9. I am familiar with the work performed by Herrera Law & Associates, PLLC and the technical consultants engaged on behalf of TCUC in connection with the *Ratemaking Proceedings*. I am responsible for coordinating and supervising the efforts of my firm's personnel pertaining to the services rendered to TCUC in the *Ratemaking Proceedings*. I have personally reviewed the billings for all work performed (legal and consulting) in connection with the *Ratemaking Proceedings*.
10. Herrera Law & Associates, PLLC transmits our firm's and consultants' invoices and backup materials showing the fees and expenses related to the *Ratemaking Proceedings* to the City of League City, Texas for review and approval. The City of League City makes available those invoices to the TCUC Steering Committee for its review. Once that review is completed, the City of League City forwards the approved invoices to CenterPoint Energy Houston Electric, LLC ("CEHE" or the "Company") for reimbursement. The City of League City provides TCUC's invoices for our firm's and consultant's services in the *Ratemaking Proceedings* to CEHE approximately monthly.
11. My firm's billings are reasonable and necessary for development of the record and advocacy of TCUC's position on the issues in the *Ratemaking Proceedings*. My firm's and consultant's invoices accurately reflect the time expended and the expenses incurred by HLA and the consultants that worked on matters related to the *Ratemaking Proceedings*. As a matter of standard operating procedure, and as part of my role in reviewing HLA's work and that of the consultants, we avoid the duplication of effort in providing our services to TCUC, including the presentation of testimony.
12. My firm's billing rates for governmental clients for our attorneys ranges from \$395.00 to \$525.00 per hour. Herrera Law & Associates' ("HLA") current billing rates for its paralegals is \$155 per hour. These billing rates are reasonable, consistent with the rates billed to other governmental clients for similar work, and comparable to rates charged by other professionals with the same level of expertise and experience. HLA's rates are at the low- to mid-range of reasonable hourly rates compared to the rates charged by other lawyers with similar experience providing similar services.

PUC Docket No. 56211:

13. For the period March 1, 2024, through May 31, 2024, TCUC incurred **\$84,457.75** in rate case expenses related to *PUC Docket No. 56211*, comprised of **\$49,234.00** in legal fees and expenses, and **\$35,223.75 in consultant fees and expenses**. The table below shows TCUC's rate case expenses by firm providing services to TCUC for the period of March 1, 2024, through May 31, 2024:

** Dr. Woolridge's invoices show his fees through mid-month, through June 16, 2024, totaling \$25,025.00; however, for consistency, HLA's invoice to TCUC is limiting Dr. Woolridge's invoice to his fees through May 31, 2024, in the amount of \$13,975.00.

14. The time and resources expended and expenses for the period March 1, 2024, through May 31, 2024, in *PUC Docket No. 56211* shown in **Exhibit A** and **Exhibit A-1 (Invoices related to PUC Docket No. 56211)** to my Affidavit were necessary to advise TCUC regarding CEHE's application, review the application, identify issues, coordinate activities, communicate with the TCUC Steering Committee regarding the status of the case, retain and work with consultants, engage in discovery, draft pleadings, develop testimony, and prepare for and attend conferences among the parties, and to review all invoices and billings regarding TCUC's rate case expenses.
15. The amounts charged for our services are reasonable and there has been no double billing of fees or expenses. Our firm does not charge its governmental clients for meal expenses. Also, we have not incurred or billed for luxury items, first-class airfare, limousines, alcohol, sporting events, or entertainment.
16. The hours spent to perform the tasks assigned to Herrera Law & Associates were necessary to complete the required tasks in a professional manner on a timely basis. My many years of experience in working with and supervising attorneys and consultants in proceedings at the Public Utility Commission of Texas, as well as the Railroad Commission of Texas, facilitates efforts to keep rate-case expenses reasonable.
17. The invoices submitted by Herrera Law & Associates include a description of services performed and time expended on each activity. The City of League City provides TCUC's invoices for our firm's and consultant's services in *PUC Docket No. 56211* to CEHE approximately on a monthly basis. Herrera Law & Associates has documented all charges with time sheets, invoices, and records. The documentation in this case is similar to that provided in many previous cases at the Commission and is in conformance with the Commission's "rate-case-expense" rule, 16 TEXAS ADMIN. CODE § 25.245.
18. The legal expenses shown in our invoices connected with *PUC Docket No. 56211* do not include luxury items. Legal expenses consist of reimbursable items such as courier services, express mail, postage and shipping, and photocopying.
19. My responsibilities, as well as other attorneys assigned to *PUC Docket No. 56211* include client communication, strategy development, overall case management, discovery review, drafting pleadings and briefs, reviewing and editing testimony, and preparing for and attending pre-hearing conferences and hearings.
20. The other attorney assigned to this proceeding is Mr. Sergio E. Herrera.

Mr. Sergio Herrera has been employed with our firm as a law clerk since 2015 and obtained a joint degree – JD/MBA from Texas Tech School of Law and the Rawls College of Business in which he graduated Magna Cum Laude. Mr. S. Herrera, licensed since 2018, has over six years of experience

in assisting and providing support in numerous rate proceedings at the PUCT and the Railroad Commission of Texas, and “CCN” cases at the PUCT, including conducting legal research, preparing discovery and pleadings related to discovery disputes, reviewing pre-filed direct testimonies, and drafting of briefs in matters before the PUCT and the courts of appeal. Mr. S. Herrera has taken on greater responsibilities by sitting first and second chair in proceedings before the Railroad Commission of Texas, and before the PUCT in DCRF, fuel-factor and surcharge cases, base rate cases, and CCN cases. As well, Mr. S. Herrera has participated in prehearing conferences, settlement meetings, and preparations for and the cross-examination of expert witnesses in contested proceedings before the Commission.

21. Ms. Mariann Wood is a certified paralegal having obtained her Associates of Applied Science in Paralegal Studies degree and certification from Kaplan University. Ms. Wood has over 18 years of experience as a paralegal and legal assistant, all in Administrative Law and more particularly in the public utility sector.
22. To assist HLA to review and evaluate CEHE’s application in *PUC Docket No. 56211*, on behalf of TCUC, HLA engaged the following consultants:
 - A. Resolve Utility Consulting, PLLC;
 - B. Norwood Energy Consulting, LLC;
 - C. J. Randall Woolridge, Ph.D.
23. **Resolve Utility Consulting, PLLC (RUC)** – David Garrett received a B.B.A. with a major in Finance, an M.B.A., and a Juris Doctor from the University of Oklahoma. He worked in private legal practice for several years before accepting a position as assistant general counsel at the Oklahoma Corporation Commission (“OCC”) in 2011. At the OCC, he worked in the Office of General Counsel in regulatory proceedings. In 2012, he began working for the Public Utility Division as a regulatory analyst providing testimony in regulatory proceedings. After leaving the OCC, he formed Resolve Utility Consulting, PLLC, where he has represented various consumer groups, state agencies, and municipalities in utility regulatory proceedings, primarily in the areas of cost of capital and depreciation. He is a Certified Depreciation Professional with the Society of Depreciation Professionals. He is also a Certified Rate of Return Analyst with the Society of Utility and Regulatory Financial Analysts. A more complete description of Mr. D. Garrett’s qualifications and regulatory experience is included in his curriculum vitae in *PUC Docket No. 56211*.
24. Mr. D. Garrett’s and RUC’s time, effort, and associated fees in *PUC Docket No. 56211* in the amount of **\$17,943.75 for the period March 1, 2024, through May 31, 2024**, to address CEHE’s proposed depreciation rates and expense are reasonable and necessary as are Mr. Garrett’s billing rate of \$225.00 per hour upon which the total of RUC’s fees are based.
25. **Norwood Energy Consulting** – Mr. Scott Norwood is the President of Norwood Energy Consulting, L.L.C (“NEC”). For over thirty-two years Mr. Norwood has participated in utility proceedings throughout the United States and specialized in areas of electric utility

regulation, resource planning, and energy procurement. A more complete description of Mr. Norwood's qualifications and regulatory experience is included in his curriculum vitae in his prefiled direct testimony filed in *PUC Docket No. 56211*. Mr. Norwood's time and efforts in *PUC Docket No. 56211* were coordinated by me and by attorneys working under my direction. Because of Mr. Norwood's extensive background, experience and familiarity with CEHE, Mr. Norwood was able to work very efficiently and accomplish his assignments with fewer hours than I would expect other consultants or expert witness would require. Mr. Norwood's time, effort and associated fees in *PUC Docket No. 56211* in the amount of **\$17,280.00 for the period March 1, 2024, through May 31, 2024**, are reasonable and necessary as are Mr. Norwood's billing rate of \$240 per hour upon which the total of his fees are based.

26. **J. Randall Woolridge, Ph.D.** is the Professor of Finance and the Goldman, Sachs & Co., and Frank P. Smeal Endowed University Fellow in Business Administration at the University Park Campus of Pennsylvania State University. Dr. Woolridge is also the Director of the Smeal College Trading Room and President of the Nittany Lion Fund, LLC. Dr. Woolridge has extensive experience in evaluating market data to assist him in assessing a regulated entity's cost of capital and the effect changes in the capital markets has a utility's cost of capital. Mr. Woolridge's resume is attached to his direct testimony in *PUC Docket No. 56211*.
27. Dr. Woolridge's time, effort, and associated fees in *PUC Docket No. 56211* in the amount of \$25,025.00 for the period March 1, 2024, through June 16, 2024, to address CEHE's requested return on equity and rate of return are reasonable and necessary as are Dr. Woolridge's billing rate of \$325.00 per hour upon which the total of his fees is based. However, for the sake of consistency with HLA's monthly invoices, HLA's invoice for services provided in May, 2024, Dr. Woolridge's invoice is limited to \$13,975.00 related to his services for the period March 1, 2024, through May 31, 2024
28. The total of TCUC's actual rate case expenses for the period March 1, 2024, through May 31, 2024, and including Dr. Woolridge's fees through June 16, 2024, is **\$116,601.50** for *PUC Docket No. 56211*. Of this amount, **\$49,234.00** are legal fees and expenses; the remaining **\$67,367.50 are consultant fees and expenses**. These amounts, including the legal fees and expenses incurred by TCUC, are reasonable given the nature of TCUC's participation in this proceeding, the number of issues involved, and the complexity, importance and scope of *PUC Docket No. 56211*.
29. Because the Public Utility Commission has not issued a final order in *PUC Docket No. 56211*, on behalf of TCUC, our firm reserves the right to amend this affidavit and TCUC's request for reimbursement as more information is gathered over the course of *PUC Docket No. 56211*. Thus, as may be necessary, I will supplement this affidavit with additional information as appropriate.

PUC Docket No. 53442:

30. In *PUC Docket No. 53442* the Commission authorized CEHE to accrue its and TCUC's rate case expenses incurred in that proceeding and deferred review of rate case expenses to

a future proceeding. See *PUC Docket No. 53442*, Order on Rehearing at Findings of Fact Nos. 63 – 65 and Ordering Paragraphs Nos. 6 – 7 (May 25, 2023). Nonetheless, to facilitate review of TCUC’s rate case expenses, I prepared for filing in *PUC Docket No. 53442* my affidavits in support of the reasonableness and necessity of TCUC’s rate case expenses. In the interest of brevity, instead of repeating my affidavit from *Docket No. 53442*, I incorporate by reference my prior affidavit filed in *Docket No. 53442* as if fully set out here. 31. In *PUC Docket No. 53442*, for the period from **April 1, 2022, through October 31, 2022**, TCUC incurred **\$67,375.50** in rate case expenses, comprised of **\$58,563.00** in legal fees and **\$8,812.50** in consultant fees as set forth in the table below:


50. Exhibit A to my Affidavit provides a summary of TCUC's actual rate-case expenses for each of the *Ratemaking Proceedings*, with a summary presented in separate tabs corresponding to each particular *Ratemaking Proceeding*. **Exhibit A-1** is comprised of the invoices for TCUC's rate-case expenses related to *PUC Docket No. 56211*. **Exhibits A-2 through A-5** is each comprised of the **additional rate-case expenses TCUC incurred** but not addressed in any one of my prior affidavits.
51. The amounts charged for HLA and the TCUC's consultants' services and shown in Exhibit A and Exhibits A-1 through A-5, are reasonable and there has been no double billing of fees or expenses. Our firm does not charge its governmental clients for meal expenses. Also, we have not incurred or billed for luxury items, first-class airfare, limousines, alcohol, sporting events, or entertainment.
52. As are most ratemaking proceedings before the Commission, CEHE's general rate case – *PUC Docket No. 56211* – presents a highly complex case involving a multitude of disciplines, including finance, economics, accounting, and engineering, each area of which presents highly technical issues requiring extensive expertise to undertake a meaningful review. In *PUC Docket No. 56211* CEHE is provides service to a major portion of in southeast Texas. As such, CEHE plays a vital role in serving the citizens of the State.
53. The same is true regarding the complexity and importance of *PUC Docket No. 53442*; *PUC Docket No. 54825*; *PUC Docket No. 54830*; and *PUC Docket No. 55993*. With exception of *PUC Docket No. 54830*, in each of these dockets CEHE proposed to amend its DCRF (distribution cost recovery factor) tariff. *PUC Docket No. 54830* is CEHE's stand-alone application for recovery of expenditures related to deployment of its mobile generation facilities.
54. The issues addressed by Herrera Law & Associates (HLA) and the consultants HLA engaged on behalf of TCUC, and the hours spent to perform the tasks TCUC undertook were necessary to complete the required tasks in a professional manner on a timely basis. As I noted above, on behalf of TCUC, our firm and team of consultants addressed a myriad of issues including return on equity, rate of return, depreciation rates and expense, a panoply of operations-and-maintenance expense issues, each area which presents particularly complex issues whose analysis requires equally sophisticated discovery, analysis, and collation of data.

55. My many years of experience in working with and supervising attorneys and consultants in proceedings at the Public Utility Commission of Texas, as well as the Railroad Commission of Texas, along with the extensive experience of TCUC's consultants, facilitates efforts to keep rate-case expenses reasonable.
56. The invoices submitted by HLA and TCUC's consultants include a description of services performed and time expended on each activity. HLA and TCUC's consultants have documented all charges with time sheets, invoices, and records. The documentation in this case is like that provided in many previous cases at the Commission and is in conformance with the Commission's "rate-case-expense" rule, 16 TEXAS ADMIN. CODE § 25.245, and more specifically, § 23.245(b)(1) – (6).
57. The legal expenses shown in HLA's invoices connected with the *Ratemaking Proceedings* do not include luxury items. Legal expenses consist of reimbursable items such as courier services, express mail, postage and shipping, and photocopying. TCUC's consultants' invoices similarly do not include luxury items or duplication of effort regarding the scope of work performed.
58. My responsibilities, as well as other attorneys assigned to the *Ratemaking Proceedings* include client communication, strategy development, overall case management, discovery review, drafting pleadings and briefs, reviewing, and editing testimony, and preparing for and attending pre-hearing conferences, settlement meetings, and hearings.
59. Because the Commission has not issued a final order in *PUC Docket No. 56211*, I will supplement this affidavit with additional information as appropriate.
60. On behalf of TCUC, our firm reserves the right to amend this affidavit and TCUC's request for reimbursement as more information is gathered over the course of *PUC Docket No. 56211*.

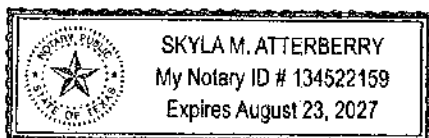
