1-5 Regarding page 14, line 15 through page 15, line 5 of the Direct Testimony of Jeffry Pollock, please provide Mr. Pollock's and TIEC's complete understanding of "single-issue (or piecemeal) ratemaking." For example, does piecemeal ratemaking only include conditions that would allow a utility to remain whole in the event that a particular cost increases outside of the utility's control (without any additional requirement to return any cost reduction to customers) or does the concept of piecemeal ratemaking also include conditions that would only require a utility to return a reduction in a single cost to customers (without any additional requirement to allow a utility to recover a particular cost increase)?

RESPONSE:

Piecemeal ratemaking would apply to any rate adjustment to reflect a change (up or down) in a single cost without any demonstration that a rate increase is needed to provide the utility a reasonable opportunity to earn its authorized rate of return. Whether piecemeal ratemaking would allow the utility to remain whole is irrelevant because it assumes that no other revenues or costs (other than the cost at issue) have changed, and the utility would earn at or above its authorized return. Absent any determination of the utility's current rate of return, one cannot conclude that a piecemeal rate change would make the utility whole.
