

The undersigned attorney for CenterPoint Energy Houston Electric, LLC (“CenterPoint Houston” or the “Company”) submits this statement under Section 4 of the protective order entered in this case.

I have reviewed the information produced by the Company today in the form of Workpapers associated with the Rebuttal Testimony of Company Witness, Mr. Myles F Reynolds sufficiently to state in good faith that certain information contained in those Workpapers is exempt from public disclosure under the Texas Public Information Act. Specifically, the information includes highly sensitive and confidential vendor pricing, account information, and commercial information relevant to costs incurred by CenterPoint Houston. 
