### APPLICATION OF CENTERPOINT ENERGY HOUSTON ELECTRIC, LLC FOR AUTHORITY TO CHANGE RATES

## **SOAH ORDER NO. 15 ADMITTING EVIDENCE AND REMAND**

On January 30, 2025, CenterPoint Energy Houston Electric, LLC, on behalf of the active parties to this proceeding, filed a Joint Motion to Admit Evidence and Remand Proceeding.<sup>1</sup> CenterPoint simultaneously filed a Stipulation and Settlement Agreement (Stipulation) that resolves all issues in this proceeding.

The Joint Motion seeks to have admitted into evidence the items identified in Attachment A to the motion, which includes the Stipulation, testimony of the parties, and testimony from CenterPoint in support of the Stipulation.

#### I. ADMITTING EVIDENCE

Consistent with the motion request, the documents listed on Attachment A to this order are admitted into the record.

#### II. DISMISS AND REMAND

Therefore, it is ORDERED that this matter is DISMISSED without prejudice from the State Office of Administrative Hearings and REMANDED to the Commission for final processing and approval.
