The undersigned attorney for CenterPoint Energy Houston Electric, LLC ("CenterPoint Houston" or the "Company") submits this confidentiality statement in accordance with section 4 of the Protective Order entered in this case.<sup>1</sup>

I have reviewed the information produced by the Company in the form of Exhibits associated with the Testimony in Support of Agreement of Company Witness, Ms. Kristie L. Colvin sufficiently to state in good faith that certain information contained in those Exhibits is exempt from public disclosure under the Texas Public Information Act ("TPIA")<sup>2</sup> and merits the protected materials designation. Specifically, the information includes highly sensitive proprietary third-party intellectual property, copyright protected material, vendor pricing information, competitively sensitive financial and commercial information, and material non-public information relevant to CenterPoint Houston. The public disclosure of this information would cause substantial competitive harm to CenterPoint Houston and the persons from whom the information is obtained. Accordingly, certain designated materials identified above are protected under Tex. Gov't Code §§ 552.101, 5502.104, and 552.110 and Tex. Util. Code § 39.001(b)(4) and merit the Protected Material ("CONF") designation they are given in CenterPoint Houston's Exhibit filing.
