#### TEXAS COAST UTILITIES COALITION'S MOTION TO ADMIT EVIDENCE

The Texas Coast Utilities Coalition of cities ("TCUC") hereby submits TCUC's Motion to Admit Evidence, and respectfully shows as follows:

#### I. MOTION TO ADMIT EVIDENCE

On June 19, 2024, TCUC filed the *Affidavit of Alfred R. Herrera Related to Rate-Case Expenses, Including Attorneys Fees Incurred by the Texas Coast Utilities Coalition of Cities*,<sup>1</sup> which, among other ratemaking proceedings, showed the rate case expenses TCUC incurred in Docket No. 56211 for the period March 1, 2024, through May 31, 2024.

To ensure the record accurately reflects TCUC's rate case expenses, TCUC respectfully requests that the Public Utility Commission of Texas enter an order admitting into evidence the following items filed in this proceeding:

The Affidavit of Alfred R. Herrera Related to Rate-Case Expenses, Including Attorneys Fees Incurred by the Texas Coast Utilities Coalition of Cities filed on June 19, 2024.

The First Supplemental Affidavit of Alfred R. Herrera Related to Rate-Case Expenses, Including Attorneys Fees Incurred by the Texas Coast Utilities Coalition of Cities filed on or about March 10, 2025.

The *First Supplemental Affidavit of Alfred R. Herrera* supports the additional rate case expenses TCUC incurred in Docket No. 56211 for the period June 1, 2024, through January 31, 2025.

TCUC is not aware of a party to this proceeding that objects to TCUC's Motion and CenterPoint has informed TCUC that it does not object to TCUC's Motion.
