APPLICATION OF CENTERPOINT \$ BEFORE THE ENERGY HOUSTON ELECTRIC, LLC \$ PUBLIC UTILITY COMMISSION FOR AUTHORITY TO CHANGE RATES \$ OF TEXAS

GULF COAST COALITION OF CITIES' SUPPLEMENTAL MOTION TO INTERVENE

COMES NOW, the Gulf Coast Coalition of Cities (GCCC) and files this Supplemental Motion to Intervene as a party to this proceeding. In support of its Supplemental Motion, GCCC shows as follows:

- 1. GCCC is made up of municipalities located within the service territory of CenterPoint Energy Houston Electric, LLC (CenterPoint).
- 2. On March 6, 2024, CenterPoint filed an application for authority to change rates. GCCC's members as well as their residents and businesses may be adversely impacted by CenterPoint's request. Therefore, GCCC has a justiciable interest in this proceeding.
- 3. Additionally, GCCC has standing pursuant to Public Utility Regulatory Act (PURA) § 33.025.1
- 4. On March 6, 2024, GCCC filed a Motion to Intervene in this proceeding, including a list of GCCC city members.
- 5. GCCC's Motion to Intervene was granted during the prehearing conference held on March 19, 2024.
- 6. GCCC requests that Brookside Village be added to the list of cities included in GCCC for this proceeding.
- 7. Docket No. 56211 constitutes a ratemaking proceeding for purposes of PURA § 33.023, and participating cities are entitled to timely reimbursement of rate case expenses.²
