On February 13, 2024, the Parties filed a settlement agreement that resolves and concludes Commission Staff's investigation of Aqua for violations of Texas Water Code (TWC) §§ 13.135 and 13.136(a), as well as 16 Texas Administrative Code (TAC) §§ 24.165(a), relating to improper billing.
