
BEFORE ME, the undersigned authority, on this day personally appeared Phoebe Ornelas, who being by me first duly sworn, on oath deposed and said the following:

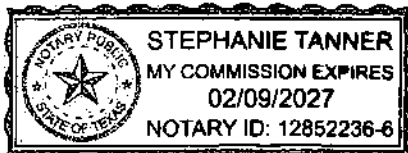


