# **DEFINITIONS**

For Account No. 800, please explain why Windermere did not provide the account holder with either the Water Credit of \$43.59 per month or the Sewer Credit of \$32.03 per month but surcharged the account holder for three months of the rate-case expense surcharge of \$39.21 per month.
- STAFF 1-3 Please refer to Windermere's first compliance report filed on June 11, 2024.
