These entities presented a justiciable interest that may be adversely affected by the outcome of this proceeding. No party objected to the above-referenced motions. Accordingly, the administrative law judge (ALJ) grants the motions.

For service of pleadings, the service list in this proceeding is available from the Public Utility Commission of Texas by emailing Docket Management at CADMOrders@puc.texas.gov and requesting a copy of the service list in Docket No. 56354. Service of pleadings is typically governed by 16 Texas Administrative Code (TAC) § 22.74. However, the Commission has issued a Second Order Suspending Rules, which has suspended certain service requirements found in 16 TAC § 22.74. Accordingly, a filing party must provide notice by e-mail of any pleading or document filed. It will be incumbent upon all other parties to obtain a copy of the pleading or document by accessing the Interchange.

All parties must provide their current address, **e-mail address**, telephone and fax numbers, if available, to all other parties and the Commission by filing and serving all parties with such information. Each party must provide the Commission and all parties with updated address, **e-mail address**, telephone, and fax information if such information changes. **The e-mail addresses**, telephone and fax numbers will be placed on the service list for the convenience of the parties. Parties are responsible for updating their own service lists to reflect changed information and the addition of any other parties.

Filing of pleadings is typically governed by 16 TAC § 22.71. However, the Commission's Second Order Suspending Rules suspended certain filing requirements found in 16 TAC § 22.71. As long as the Second Order Suspending Rules remains in effect, all parties must file any pleading or document with the Commission solely through the Interchange on the Commission's website (https://interchange.puc.texas.gov/filer) and provide notice, by e-mail, to all other parties that the pleading or document has been filed with the Commission, unless otherwise ordered by the presiding officer. It will be incumbent upon all other parties to obtain a copy of the pleading or document by accessing the Interchange.

III. Denying Interventions

On January 7, 2025, Justin Long filed a request to intervene on behalf of the Long Household and as the ratepayer class representative of the Beechwood Community, but signed the document as "authorized representative, Beechwood HOA." In Order No. 14 filed on January 31, 2025, Mr. Long was ordered to clarify how many interventions he is filing and provide separate forms for each; provide proof of authority to act, as required under 16 TAC § 22.101(a); and clarification as to whether individuals within the Beechwood Community have also intervened and

which individuals. Subsequent to Order No. 14, Mr. Long filed an intervention request form on his behalf and one with a Jennifer Long. As noted above, the individual intervention requests of Mr. and Ms. Long are granted; however, the January 7, 2025 request to intervene by John Long, for the Beechwood Community or Beechwood HOA, is denied.

On January 14 2025, Adam Gazda filed a request to intervene under confidential seal. Mr. Gazda's requests to intervene is denied because it was filed confidentially and therefore could not be reviewed.
