**UNDINE, LLC’S MOTION TO OBJECT TO LATE FILED INTERVENTIONS**

Undine, LLC (Undine) files this Motion to Object to Late Filed Interventions (Motion). In support of its Motion, Undine respectfully shows the following:

**I. MOTION TO OBJECT TO LATE FILED INTERVENTIONS**

On March 14, 2025, the Administrative Law Judge (ALJ) set February 3, 2025, as the intervention deadline, given that date is 45 days after Undine filed its Amended Application.<sup>1</sup> Undine inadvertently failed to timely notice water customers located in Tejas Landing and sewer customers in Cold River Ranch due to a clerical error.<sup>2</sup> Undine provided notice to those customers on or about February 26, 2025, and March 7, 2025, respectively.<sup>3</sup>

During the prehearing conference on March 27, 2025, the ALJ ordered that the intervention deadline for all Undine ratepayers, excluding the water customers in the Tejas Landing system and all sewer customers in the Cold River Ranch system who were inadvertently not provided timely notice, remain February 3, 2025. The Tejas Landing and Cold River Ranch customers who were provided late notice must intervene by April 21, 2025. Accordingly, Undine asks that any motions to intervene that have not yet been granted by the Commission be denied if they were filed by customers not affiliated with Tejas Landing or Cold River Ranch. Undine also asks that any future requests to intervene be denied from customers who were noticed on or about December 19, 2024.

**II. LIST OF INTERVENORS**

The following individuals filed a request to intervene in this proceeding after February 3, 2025, and their request to intervene has not yet been granted.

None of the individuals listed above are water customers from Tejas Landing or sewer customers from Cold River Ranch that were provided late notice. Consequently, since the ALJ set February 3, 2025, as the intervention deadline for Undine ratepayers not affiliated with Tejas Landing or Cold River Ranch, the listed individuals should not be granted party status.


### **III. CONCLUSION**
