**AGREED STATUS REPORT**


On July 17, 2025, Undine, LLC, Staff for the Public Utility Commission of Texas, the Office of Public Utility Counsel, Woods of Greenshores Property Owners Association, Inc., Greenshores on Lake Austin Property Owners Association, Howard Ludwig (designated representative for the EMCAD system), and Vincent Zinnante (designated representative for the Nerro system, excluding Bayridge and Oaks at Houston Point) (collectively, Parties) filed a Joint Motion to Abate the procedural schedule in this proceeding. The Administrative Law Judge issued SOAH Order No. 10 cancelling the hearing set for July 23, 2025.

As indicated in the Agreed Status Report filed on August 11, 2025, Parties have reached an agreement in principle and are coordinating efforts to prepare a stipulation and settlement agreement. Parties request continued abatement to allow time for finalizing the settlement. Parties expect to file settlement documents, or a status report, on or before September 10, 2025.


