ORDER NO. 2 FINDING PETITION ADMINISTRATIVELY COMPLETE, FINDING NOTICE SUFFICIENT, AND ESTABLISHING PROCEDURAL SCHEDULE

This Order addresses the sufficiency of the March 15, 2024 petition of Walton Texas, LP to amend the City of San Marcos' certificate of convenience and necessity (CCN) number 20116 in Caldwell County by streamlined expedited release.

1. Finding Petition Administratively Complete and Notice Sufficient

In its March 15, 2024 petition, Walton Texas Walton Texas stated that it mailed a copy of its petition to the CCN holder, San Marcos, by certified mail on the day the petition was filed with the Commission.

On April 15, 2024, Commission Staff filed a recommendation on the administrative completeness of the petition, notice and proposed a procedural schedule.

The administrative law judge (ALJ) finds the petition administratively complete and notice sufficient. The finding of administrative completeness does not address the merits of the petition.

II. Establishing Procedural Schedule

Under Texas Water Code (TWC) § 13.2541, the granting of streamlined expedited release initiates an appraisal process to determine the amount of monetary compensation that may be owed by the landowner to the certificate holder for the tract of land that was released. Therefore, an order granting approval for streamlined expedited release is interim in nature and, in the event the requested release is approved, the docket will continue for the purpose of determining the issue of compensation.
