# COMMISSION STAFF'S REQUEST FOR EXTENSION

On March 19, 2024, New Water Systems, Inc. and Derby ING LLC (collectively, Applicants) filed an application for the sale, transfer, or merger of facilities and certificate of convenience and necessity rights in Frio County.

On April 25, 2024, the administrative law judge filed Order No. 2, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a recommendation on sufficiency of notice and a proposed procedural schedule by June 3, 2024. Therefore, this pleading is timely filed.

## I. REQUEST FOR EXTENSION
