RE: Texas Energy Fund In-ERCOT Generation Loan Program - Notice of Intent List

Project No. 56455

Between May 1, 2024, and May 31, 2024, the Commission received 125 notices of intent (NOIs) to apply for a loan through the Texas Energy Fund's (TEF) In-ERCOT Generation Loan Program. The NOIs denote applicants' intent to request loans to finance 55,908 megawatts (MW) of proposed dispatchable power generation projects.

As part of the NOI submission process, applicants were required to file a letter in Project No. 56455 that includes the applicant's legal name and the MW capacity that the requested loan amount will finance. The attached table lists the applicant's legal name and MW capacity for each NOI.

Commission staff has compiled this list for convenience of reference. The data is sourced solely from applicants' filed NOI letters.
