COMMISSION STAFF'S CORRECTION TO THE PROPOSED ORDER

On April 5, 2024, Denton Oliver Creek, LP (Denton Oliver Creek) filed a petition for streamlined expedited release from Aqua Texas, Inc.'s (Aqua Texas) water certificate of convenience and necessity (CCN) number 13201 in Denton County under Texas Water Code (TWC) § 13.2541(b) and 16 Texas Administrative Code (TAC) § 24.245(h). Denton Oliver Creek asserts that the land is at least 25 contiguous acres, is not receiving water service, and is located in Denton County, which is a qualifying county.

On November 6, 2024, the Office of Policy and Docket Management filed a Proposed Order (PO), directing the parties to file corrections or exceptions to the PO by November 20, 2024. Therefore, this pleading is timely filed.

I. PROPOSED CORRECTION

The Staff (Staff) of the Public Utility Commission of Texas (Commission) has reviewed the PO and respectfully proposes the following correction to proposed Finding of Fact No. 12 for the reason discussed below.

Finding of Fact No. 12

Staff proposes that the order number and the date that the order was filed be corrected as follows:

12. In Order No. 5 filed on September 20, 2024, the ALJ found notice sufficient.

Staff proposes this revision to reflect the correct order number and date in which the ALJ found the notice to be sufficient in the docket.
