JOINT NOTICE OF AGREEMENT REGARDING COMPENSATION

In accordance with Texas Water Code § 13.2541 and 16 Tex. Admin. Code § 24.245, Denton Oliver Creek, LP (“Petitioner”) and CCN Holder, Aqua Texas, Inc. (“Aqua”) (cumulatively, the “Parties”) file this joint notice of agreement regarding compensation in this proceeding.

Petitioner filed its Petition for Streamlined Expedited Release (SER) on April 5, 2024, which was granted by the Commission on January 16, 2025. On March 3, 2025, Petitioner and Aqua reached an agreement pursuant to which the Parties agreed on an amount to be paid to Aqua as compensation for the release. A copy of the agreement including the compensation amount is attached and submitted confidentially as Attachment A to this joint filing. This filing is made in compliance with 16 TAC § 24.245(i)(1). Petitioner and Aqua respectfully request that the Commission enter an order determining compensation based on the Parties’ agreement.

16 TAC § 24.245(i)(1) establishes the deadline for the CCN holder and landowner to make a joint filing stating an agreed amount of monetary compensation to be paid to the CCN holder as 70 days after the Commission has granted SER, therefore this agreement is timely filed. Neither this agreement nor the agreed compensation amount included in the agreement should be construed as precedential in any way for future proceedings at the Commission. Commission Staff has been informed of this agreement and has not expressed any opposition to the requested relief.

Counsel for Aqua has authorized the filing of this pleading.
