#### AGREED PROPOSED PROCEDURAL SCHEDULE

On April 22, 2024, Daniel Deweber and Prairie Branch Properties LLC (collectively, Complainants) filed a formal complaint against Amon Carter Lake Water Supply Corporation (Amon Carter Lake WSC) for refusal to provide water service.

On November 12, 2024, the administrative law judges (ALJs) for the State Office of Administrative Hearings (SOAH) filed SOAH Order No. 2, requiring the Complainants, Amon Carter Lake WSC, and the Staff (Staff) of the Public Utility Commission of Texas (Commission) (collectively, Parties) to file an agreed proposed procedural schedule or, if no agreement is reached, to separately file competing proposed procedural schedules by November 21, 2024. Therefore, this pleading is timely filed.

#### I. PROPOSED PROCEDURAL SCHEDULE

Staff has conferred with the Complainants and attempted to confer with Amon Carter Lake WSC and is authorized to propose the following procedural schedule as an agreed proposed procedural schedule with the Complainants in accordance with SOAH Order No. 2. As of this filing, Amon Carter Lake WSC has not responded to Staff's attempt to confer.

For the reasons discussed above, Staff and the Complainants respectfully request an order adopting the proposed procedural schedule.
