JOINT MOTION TO ADMIT EVIDENCE AND REMAND PROCEEDING

Entergy Texas, Inc. ("ETI") on behalf of itself and the Staff of the Public Utility Commission of Texas ("Commission Staff") (collectively, "Movants") submit this Joint Motion to Admit Evidence. Cities¹ and Texas Industrial Energy Consumers ("TIEC") are unopposed.

I. <u>MOTION TO ADMIT EVIDENCE</u>

The Movants request that the following evidence be admitted:

- a. ETI's Application, including all attachments; the direct testimony, exhibits and workpapers of Mark R. Delevan and Jay Andrew Lewis, Jr.; and the affidavit and attachments of Erika N. Garcia and Molly Mayhall Vandervoort filed on May 1, 2024 (Interchange Item 2);
- b. ETI's proof of notice filed on May 9, 2024 (Interchange Item 7);
- c. ETI's Errata No. 1 filed on July 25, 2024 (Interchange Item Nos. 25 and 26).
- d. The Stipulation and Settlement Agreement and attachments filed on October 18, 2024;
- e. The testimony in support of the agreement of ETI witness Mark R. Delavan filed on October 18, 2024; and
- f. The testimony in support of the agreement of [Staff witness].
