Entergy Texas, Inc. (“ETI” or “the Company”), Staff of the Public Utility Commission (“Staff”), and Texas Industrial Energy Consumers (hereinafter the “Parties”) submit the following agreed proposed procedural schedule.

Parties also present the following additional agreements:

- For responses to written discovery on Intervenor and Staff Direct, Intervenor and Staff Cross-Rebuttal, and ETI Rebuttal Testimonies:
 - Responses to Requests for Information (“RFIs”) shall be filed within five working days of receipt of the discovery;
 - Objections to RFIs shall be filed within three working days of receipt of the discovery;
 - Motions to compel shall be filed within four working days of receipt of the objections (or at the hearing, whichever is earlier); and
 - Responses to motions to compel shall be filed within four working days of receipt of the motion to compel (or at the hearing, whichever is earlier).
- Workpapers due 1 business day after testimony; and
- Drafts of testimony and the emails transmitting the drafts are not discoverable.

II. Prehearing Conference

In State Office of Administrative Hearings (“SOAH”) Order No. 1 in this proceeding, the SOAH Administrative Law Judge (“ALJ”) scheduled a prehearing conference on May 20, 2024. The SOAH ALJ stated in that order that ETI may file an agreed motion to cancel the prehearing conference if the motion also includes an agreed procedural schedule that complies with SOAH Order No. 1 by May 17, 2024. This agreed pleading is intended to address and comply with all issues raised in SOAH Order No. 1. Accordingly, ETI moves to cancel the prehearing conference and is authorized to represent that no other party opposes this motion.

III. Conclusion

In consideration of the preceding, the Parties respectfully request that the SOAH ALJ approve the proposed procedural schedule and additional agreements presented above, cancel the prehearing conference, and grant such other relief to which they are entitled.


