SWEPCO AND COMMISSION STAFF'S PROPOSED CORRECTIONS TO THE PROPOSED ORDER

Southwestern Electric Power Company (SWEPCO) and Staff of the Public Utility Commission of Texas (Commission) respectfully submit the following proposed corrections to the Proposed Order for purposes of accuracy and clarity.

I. INTRODUCTION

On October 9, 2024, the Office of Policy & Docket Management (OPDM) issued a Proposed Order in this case to be considered by the Commission at a future open meeting. OPDM's cover memorandum directed parties to file any corrections to the Proposed Order by October 23, 2024. Accordingly, these proposed corrections are timely filed.

II. PROPOSED CORRECTIONS

SWEPCO and Commission Staff propose the following corrections to proposed Finding of Fact No. 45 and Ordering Paragraph Nos. 4 and 5 for the reasons discussed below.

Finding of Fact No. 45

SWEPCO and Commission Staff propose that the second sentence of proposed Finding of Fact No. 45 be corrected as follows:

45. In the affidavit, Ms. Melhem stated that SWEPCO's rate-case expenses incurred in its immediately previous EECRF proceeding, Docket No. 54948, in the amount of \$21,789 were reasonable and necessary.

SWEPCO and Commission Staff propose this revision to correct a minor typographical error.

Ordering Paragraph No. 4

SWEPCO and Commission Staff propose that proposed Ordering Paragraph No. 4 be corrected as follows:

4. The Commission grants SWEPCO's request for a good cause exception and revises SWEPCO's cost cap for the residential customer class to be equal to SWEPCO's 2024 2025 EECRF rate for the residential customer class.

SWEPCO and Commission Staff propose this revision for accuracy and consistency with Finding of Fact No. 42, which explains SWEPCO's request that the Commission establish a revised cost cap for the residential customer class that is equal to SWEPCO's 2025 EECRF rate for the residential customer class.

Ordering Paragraph No. 5

SWEPCO and Commission Staff propose that proposed Ordering Paragraph No. 5 be corrected as follows:

5. Within ten days of the date of this Order, SWEPCO must provide the Commission with a clean copy of the EECRF tariff schedules approved by this Order to be stamped Approved and retained by Central Records.

SWEPCO and Commission Staff propose a minor typographical correction of the plural reference to "EECRF tariff schedules" to "EECRF tariff schedule" for clarity and accuracy.

III. CONCLUSION

SWEPCO and Commission Staff respectfully request that the Commission modify the Proposed Order as indicated above.
