ALJ Katie Moore Marx has been tampering with docket no. 56589 in a criminal and punishable manner. She has already blocked our appeal [56589-178] against unlawful Order No. 9 [56589-176]. 16 Texas Administrative Code § 22.3(e)(5) prevents the ALJ from issuing such order because a motion to recuse [56589-169] pends before the commission.
