## ORDER NO. 3 SETTING DEADLINE TO REQUEST A HEARING, DENYING APPLICATION FOR TEMPORARY INJUNCTION, AND REQUIRING CLARIFICATION FROM MR. WAKILEH

On May 20, 2024, George Wakileh filed a copy of a notice of termination for water service for his account from Grand Lakes MUD No. 2 and an application for a temporary injunction. The administrative law judge has identified at least two Commission rules under which Mr. Wakileh's request could be brought, 16 Texas Administrative Code (TAC) §§ 22.242(h) or 24.155(a). By May 24, 2024, Mr. Wakileh must clarify under which rule, or any other Commission statute or rule, he is seeking relief.

Mr. Wakileh also requested a temporary injunction against Grand Lakes MUD No. 2 to preserve the status quo and preventing any enforcement actions regarding the disconnection of service notice he received. Because the Commission does not have any rules regarding temporary injunctions and Mr. Wakileh has not cited any authority for the Commission to be able to issue a temporary injunction, Mr. Wakileh's request for a temporary injunction is denied.

Finally, Mr. Wakileh signed the May 20, 2024 application for temporary injunction as "George Wakileh, on behalf of the 92 ratepayers residing within the jurisdiction of Grand Lakes MUD No. 2" but, after further review of the initial petition, it appears that the residents Mr. Wakileh purports to represent only signed a general petition. Nowhere on the pages the residents signed is there an agreement between them and Mr. Wakileh for his representation in this proceeding at the Commission. Under 16 Texas Administrative Code § 22.101(a), the ALJ requires Mr. Wakileh to file proof that the 92 ratepayers residing within the jurisdiction of Grand Lakes MUD No. 2 requested that Mr. Wakileh file the petition on their behalf and represent them in front the of the Commission. By June 3, 2024, Mr. Wakileh must file such proof.
