SOAH ORDER NO. 2
GRANTING AGREED PROPOSED PROCEDURAL SCHEDULE AND
FINDING APPLICATION AND NOTICE SUFFICIENT

I. ADOPTING PROCEDURAL SCHEDULE

On June 6, 2024, Oncor Electric Delivery Company LLC (Oncor) and staff (Staff) of the Public Utility Commission of Texas (Commission) filed proposed an agreed motion in the event that no motion to intervene was timely filed by the June 20, 2024 intervention deadline as set forth in the Commission's Order of Referral and Preliminary Order. No motions to intervene were filed. Accordingly, the proposed procedural schedule, detailed below, is **ADOPTED**, and it shall govern this proceeding:



Deadline for Staff to review the application and file recommendations or comments on the sufficiency of the application	June 18, 2024
Intervention Deadline under the Preliminary Order	June 20, 2024
Deadline for intervenors to request a hearing on the merits; deadline for intervenor comments if no hearing is requested	June 20, 2024
Deadline for Oncor to file any reply to the recommendations or comments on the sufficiency of the application	June 21, 2024
Deadline under the Preliminary Order for the presiding officer to issue a written order concerning material deficiencies in the application, if any	June 25, 2024
Deadline for Commission Staff to request a hearing on the merits; deadline for Staff's recommendation on final disposition if no hearing on the merits is requested	July 8, 2024
Deadline for Oncor to request a hearing or respond to intervenor comments and Staff recommendation on final disposition; or deadline for the parties to file a joint motion for remand, joint motion to admit evidence, and joint proposed notice of approval, including proposed findings of fact, conclusions of law, and ordering paragraphs	July 16, 2024
If applicable, administrative review completed 80 days from the date of the filing of the application	Aug. 9, 2024
Commission Deadline for Decision under the	Nov. 18, 2024¹

¹ The 180-day deadline falls on Sunday, November 17, 2024, a day that SOAH and the Commission will be closed. Therefore, under 16 Texas Administrative Code § 22.4(a), the deadline moves to the next day the Commission is open for business, Monday, November 18, 2024.

II. SUFFICIENT APPLICATION AND NOTICE

On June 18, 2024, Staff recommended that Oncor's application and notice be found sufficient for further processing. There were no objections. Accordingly, Oncor's application and its provision of notice of its application are deemed sufficient.
