**ORDER NO. 7**  
**FINDING NOTICE SUFFICIENT AND ESTABLISHING PROCEDURAL SCHEDULE**

This Order addresses the sufficiency of notice of the May 13, 2024 application of Henry M. Garza dba Cielo Azul Ranch and Cielo Azul Agua LLC for approval of the sale, transfer, or merger of facilities and certificate rights in Hays County.

On November 8, 2024, Cielo Azul filed the following: (1) the affidavit of Allison Chambers, office manager of Cielo Azul, attesting that notice was sent via first-class mail to all current customers, neighboring utilities, and affected parties on November 6, 2024; (2) the affidavit of Ms. Chambers attesting that there are no landowners owning tracts of land over 25 acres wholly or partly inside the requested area to be added; (3) representative copies of the notice and maps provided; and (4) a list of individuals and entities to whom notice was provided.

On December 10, 2024, Commission Staff filed a recommendation on the sufficiency of notice and proposed a procedural schedule.

The administrative law judge finds notice sufficient and establishes the following procedural schedule for the continued processing of this docket:
