

I am writing to the Public Utilities Commission concerning the rate increases for the minimum billing per meter that has been implemented by the Leroy Tours Gerald Water Supply Corporation. I understand that costs will increase occasionally due to inflation and other factors. My concern is that by increasing minimum rates instead of usage rates per meter the cost of increases will unfairly affect people with limited and lower incomes in the community. We have several high-volume users on the system, and they are paying the same monthly increase as the minimum users in single-family low-income households. Many of these people are widows, widowers, and single parents who just can't afford these increases. They are in effect subsidizing the high-volume users in the system.

We have 598 meters on the system and 95 of those members have signed the enclosed petition asking for the PUC to help us find a fair and equitable solution for this issue. We already know that there are likely to be more increases and our goal is to place the costs fairly on the users who are putting the strain on our water supply. An added benefit would be to encourage conservation by charging more per gallon rather than increasing minimum billing.

The old rate charged by the service provider was \$39.57 monthly base rate minimum plus tax and usage, and the new rate is \$53.57 monthly base rate minimum plus tax and usage. Raising the monthly base rate minimum forces low volume users (most of whom are also low income users) to subsidize high volume users. We recognize that rate increases are sometimes necessary. However, if volumetric usage rates were increased instead of monthly base rates, the burden would be spread fairly among all users.
