**COMMISSION STAFF'S SUPPLEMENTAL RECOMMENDATION ON THE  
ADMINISTRATIVE COMPLETENESS OF THE APPEAL AND SUFFICIENCY OF  
NOTICE**

On May 14, 2024, ratepayers of Leroy-Tours-Gerald Water Supply Corporation (Leroy-Tours-Gerald WSC) filed an appeal of the decision by Leroy-Tours-Gerald WSC's board of directors to change water rates under Texas Water Code (TWC) § 13.043(b)(1) and 16 Texas Administrative Code (TAC) § 24.101(c)(1).

On July 3, 2024, the administrative law judge filed Order No. 4, setting a deadline of August 5, 2024, for the Staff (Staff) of the Public Utility Commission of Texas to file a supplemental recommendation on the administrative completeness of the appeal and the sufficiency of notice by August 5, 2024. Therefore, this pleading is timely filed.

**I. RECOMMENDATION**

Order No. 4 directed Staff to file a supplemental recommendation on the administrative completeness of the appeal and the sufficiency of notice following an opportunity for parties to respond to Leroy-Tours-Gerald WSC's Motion to Dismiss. Staff continues to support its Recommendation on the Sufficiency of Notice filed on July 1, 2024.

**II. CONCLUSION**

Staff respectfully requests the entry of an order consistent with Staff's July 1, 2024 recommendation.
