LEROY TOURS GERALD WATER SUPPLY CORPORATION'S PROPOSED PROCEDURAL SCHEDULE

COMES NOW, the Leroy Tours Gerald Water Supply Corporation ("LTG") and offer LTG's Procedural Schedule and would respectfully show the following:

I. PROCEDURAL HISTORY

On May 14, 2024, the Petitioners filed their Ratepayers' appeal of the decision by Leroy Tours Gerald Water Supply Corporation to change rates (Petition) under Texas Water Code (TWC) § 13.043(b)(4) and 16 Texas Administrative Code (TAC) § 24.101 (c)(4). The Administrative Law Judge issued Order No. 1 requiring the parties, by June 12, 2024, to file comments regarding how to proceed with the Petition and to propose a procedural schedule. Therefore, this Response is timely filed.

II. LTG'S PROPOSED PROCEDURAL SCHEDULE

LTG contacted the ratepayers representative via telephone regarding a procedural schedule. The ratepayer's representative did not express any preference for a particular procedural schedule. LTG also contacted PUC staff regarding the schedule. Based on feedback from Commission Staff, LTG is hereby offering the following procedure and schedule, which is based on 16 TAC §22.244.

III. PROPOSED PROCEDURE / SCHUEDULE FOR VERIFICATION

July 8, 2024	LTG will file with the Commission a statement of review and verification
	of signatures together with supporting written affidavits sworn to by a
	board officer.
August 5, 2024	Petitioner's statement of response to LTG's statement of review (not to
	exceed thirty days).
August 9, 2024	Staff's reply to LTG's statement of review.
August 21, 2024	If applicable, LTG's proposed procedural schedule for the appeal.

IV. CONCLUSION AND PRAYER

For the foregoing reasons, LTG respectfully requests that the Commission enter an order adopting the Procedural Schedule proposed herein.
