**COMMISSION STAFF'S REQUEST FOR EXTENSION**

On May 14, 2023, ratepayers (Ratepayers) of Leroy-Tours-Gerald Water Supply Corporation (Leroy-Tours-Gerald WSC) filed an appeal of the decision by Leroy-Tours-Gerald WSC's board of directors to change water rates under Texas Water Code § 13.043(b)(4) and 16 Texas Administrative Code (TAC) § 24.101(c)(4).

On June 17, 2024, the administrative law judge (ALJ) filed Order No. 2, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a recommendation on the sufficiency of notice and propose a procedural schedule, if appropriate, by June 24, 2024. Therefore, this pleading is timely filed.

**I. REQUEST FOR EXTENSION**

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff requires additional time to review the docket and to prepare its recommendation. Staff respectfully requests that its deadline to file its recommendation be extended to July 1, 2024.

**II. CONCLUSION**

For the reasons discussed above, Staff respectfully requests on order extending Staff's deadline to file its recommendation to July 1, 2024.
