CITIES SERVED BY TEXAS NEW MEXICO POWER COMPANY'S MOTION TO INTERVENE

COMES NOW, the Cities Served by Texas New Mexico Power Company (Cities)¹ and files this Motion to Intervene as a party to this proceeding. In support of its Motion, Cities shows as follows:

- 1. Cities is a coalition of municipalities located within the service territory of Texas-New Mexico Power Company (TNMP).
- 2. On May 31, 2024, TNMP filed an Application to Adjust its Energy Efficiency Cost Recovery Factor (EECRF) and Related Relief. Cities' members, as well as their residents and businesses, may be adversely impacted by the relief requested by TNMP regarding its EECRF. Therefore, Cities has a justiciable interest in this proceeding.
- 3. Additionally, Cities has standing to participate in this proceeding pursuant to Public Utility Regulatory Act (PURA) § 33.025.²
