## THE BVRT UTILITIES' SUPPLEMENTAL RESPONSE TO COMMISSION STAFF'S REQUEST FOR INFORMATION NO. 1-10

**RESPONSE**: This response is subject to a pending objection. Pursuant to and without waiving this objection, and based on an agreement between the parties, BVRT provides the following response:

In December 2023, BVRT substantially completed Phase 2 of its WRRF plant at Windy Hill Utility (WHU) totaling \$6,915,699 and Phase 4 of its WRRRF plant at Forest Glen Utility (FGU) totaling \$6,911,926, whereby BVRT moved these assets from WIP to the following fixed asset categories as of 2023 year end:

\$12,414	Land Related
\$6,193,726	Wastewater Treatment Plant
\$29,699	Structures – WRRF
\$3,624.065	WWTP Site Work & Improvements
\$901,003	Power Generation Equipment – WRRF
<u>\$2,266,718</u>	WWTP Equipment
<u>\$13,027,625</u>	Total
