TWU'S RESPONSE TO OPUC'S SEVENTH RFI

- b. The invoice reference 100623818 initially went into construction work in progress in April 2022. It was subsequently placed into service in January 2023. The invoice reference 10063319 was not found in "Attachment Staff 2-2."
- j. The referenced transactions were inadvertently assigned to NARUC Account 610 Purchased Water. Document 100630022 relates to chemical costs allocated to both water and wastewater (Allocated Materials and Supplies GL Account). Document 100750648 relates to travel costs allocated to both water and wastewater (Allocated Other Operating Expenses GL Account). Document 100750668 relates to the installation of pressure gauges at a wastewater plant (Repair and Maintenance GL Account). The other 10 documents relate to TCEQ wastewater permit fees for two acquired systems (TCEQ Fees for Wastewater Permit GL Account).
