DEFINITIONS

Provide all calculations for TWU's portion of the 2022 and 2023 Texas Franchise Tax. If TWU requested an extension for its report due May 2024, please provide a copy of the extension request
- STAFF 5-2 Please provide the State Gross Receipts Tax Reports for 2022 and 2023 in which TWU's operations that generated gross receipts tax were reported, including all supporting documentation and workpapers. Provide all calculations producing TWU's portion of the 2022 and 2023 gross receipts tax.
- STAFF 5-3 Please provide copies of income tax forms filed with the IRS for the test year which include the Company's utility operations. Please include copies of federal forms W-2, W-3, and 1099, and 1096.
