**CSWR-TEXAS UTILITY OPERATING COMPANY, LLC'S DESIGNATION OF  
PROTECTED MATERIALS**

This statement is being filed to comply with Paragraph 4 of the Protective Order relating to the procedures for the designation of Protected Materials.

Certain materials responsive to the request listed below contain information that is considered to be Protected Material or Highly Sensitive Protected Material and is protected from public disclosure pursuant to the Public Utility Regulatory Act (PURA),<sup>1</sup> the Texas Public Information Act (TPIA)<sup>2</sup> and the Protective Order entered in this proceeding. The undersigned counsel for CSWR-Texas Utility Operating Company, LLC (CSWR-Texas) has reviewed the information sufficiently to state in good faith that the information is exempt from public disclosure under the Public Information Act and merits the confidential designation.

*Highly Sensitive Protected* Attachment Staff 1-2 to CSWR-Texas's Second Supplemental Response to Commission Staff's First Request for Information has been designated as highly sensitive because the materials are of such a highly sensitive nature that making copies of such documents or information or providing access to such documents would expose the Company to unreasonable risk of harm. Highly sensitive information protected under the Protective Order includes: (a) customer-specific information protected by § 32.101(c) of the Public Utility Regulatory Act; (b) contractual information pertaining to contracts that specify that their terms are confidential or that are confidential pursuant to an order entered in litigation to which the

producing party is a party; (c) market-sensitive fuel price forecasts, wholesale transactions information and/or market-sensitive marketing plans; and (d) business operations or financial information that is commercially sensitive. The requested information is designated as highly sensitive because it contains business operations or financial information that is commercially sensitive. Therefore, this information is exempt from public disclosure under Tex. Gov't Code §§ 552.101 and/or 552.110.

Pursuant to the Protective Order, “representatives of the Reviewing Party who are authorized to view Highly Sensitive Protected Material may review the copy of Highly Sensitive Protected Materials at the office of the Reviewing Party’s representative designated to receive the information.” Hard copies of these materials will be filed with the Commission’s Central Records division in accordance with 16 TAC § 22.71(d) and the Commission administrative law judge’s direction in Order No. 18 in Docket No. 56687.<sup>3</sup>
