#### DOCKET NO. 54634 BASE RATE TRUE-UP

**APPLICABILITY:** To all retail customers in Texas, in addition to all rates under the applicable tariff.

For electric service from October 1, 2024 through September 30, 2025, the Base Rate Revenue Trueup Factors will be billed to all applicable customers except for the transmission voltage level, Primary Low Load Factor Service, and service agreement customers shown below. Base rate revenue excludes Fuel, Taxes, Franchise Fees, and any applicable Riders, including EECRF, DCRF, TCRF, etc. From the rates approved by the Public Utility Commission of Texas in Docket No. 54634 and 53766 the net total amount of the charges for all applicable customer classes is \$35,442,814.

Method of Calculation

(a) For all applicable Texas retail customers, except for Primary Low Load Factor, service agreement, and transmission voltage level customers:

#### DOCKET NO. 54634 BASE RATE TRUE-UP

(b) For all, Primary Low Load Factor Service, transmission voltage level service, and service agreement customers, the monthly amounts are determined based on the difference in the amount each customer would have been billed under rates authorized in Docket No. 54634 and the amount billed during the period that the under recovery accumulated. The monthly surcharge for each of these customers is determined to the nearest whole dollar. The total amount of the surcharge for the customers on each of these rate schedules is spread over the 12-month recovery period (October 2024 through September 2025) and are as follows:
