2. On July 25, 2024, Oncor Electric Delivery Company (“Oncor”) filed an application seeking approval of a new, double-circuit 345-kilovolt transmission line between Oncor’s planned Reiter Switch in Ector County and Oncor’s existing Tesoro Switch in Midland County.

3. The proposed routes and segments on the proposed transmission line cross property that has been developed or is being developed by Oxy. The placement of the transmission line will impact Oxy’s ability to pursue existing and planned development. Accordingly, Oxy has a justiciable interest in the outcome of this proceeding and should be admitted as an intervenor.

4. Oxy respectfully requests that the Commission grant this Motion to Intervene and be admitted as an intervenor in this proceeding for all purposes, and for such other relief to which it may be justly entitled.
