Dear Public Utility Commission of Texas:

On October 25, 2023, Gideon Water LLC filed a request in Docket No. 53485 for reconsideration of the final approval of the tariff that was approved on July 31, 2023. The approved tariff contained an error that had been brought to Staff's attention during the Consent process. (See Attachment A-1). On October 30, 2023, Administrative Law Judge (ALJ), Isaac Ta, issued Order No. 18 - denying request for reconsideration.

On October 31, 2023, Gideon Water LLC filed a request in Docket No. 53485 for a Tariff Change per TWC 13.244 (e)(1) to correct a clerical or typographical error (See Attachment B-1). On November 2, 2023 ALJ, Isaac Ta, issued Order No. 19 – declining to rule on pending request. The ALJ indicated that Gideon Water was free to file its request in a new docket.

On November 9, 2023, Gideon Water LLC filed a request in Docket 55819 requesting that the change be made in accordance with TWC 13.244 (e)(1) to correct a clerical or typographical error. Over the next several months, staff filed several filings in Docket 55819 further detailing the issues and attempting to make the case that the correction should be granted. On April 22, 2024, ALJ Denmark filed a Proposal for Decision denying the request stating that TWC 13.244 (e)(1) authorized the Executive Director to make revisions to clerical or typographical in CCNs, but not in tariffs. Gideon does not agree since tariffs are part of CCNs. However, In Order No. 3 of Docket 55819, ALJ Denmark asked if this issue might be more properly processed as a tariff revision under 16 TAC § 24.25(b)(3), hence this request.

Given the extensive evidence presented in the October 25, 2023 filing that indicated the error was due to a PUC mistake, and had been previously noted by Giden Water LLC, Gideon Water LLC is now requesting that the change be made in accordance with 16 TAC § 24.25(b)(3) to revise the tariff to reflect 0 gallons included, as was the intent from the very beginning. Further extensive information regarding the issues at hand can be found in the March 6, 2024 Motion for Order Nunc Pro Tunc and the April 1, 2024 Motion for Reconsideration of Order No. 20, both in Docket No. 53485.

Per 16 TAC § 24.25(b)(3)(B), enclosed in Attachment C-1 is a copy of the original tariff and a red-lined copy of the proposed tariff revisions clearly showing the proposed changes.

Dear Public Utility Commission of Texas:

Please accept this correspondence as a request for reconsideration of the final tariff that was filed with the Notice of Approval on 7/31/2023.

Please accept the following as corroboration for the need for reconsideration.

Gideon Water, LLC filed an application for a new water CCN in Montgomery County on April 12, 2022. The submittal included the requested tariff, which did not/nor never did include any included any gallons with any meter size.

On December 7, 2022, I received notice of an extension filed by staff due to consent forms not having been filed by the applicant. I emailed staff attorney, John Harrison, that same day to let him know that I had never received the consent form and associated tariff, certificate and map.

On December 12, 2022, John Harrison emailed me the consent form, the CCN service area map, the water certificate and the proposed water tariff. Upon review of the documents emailed to me, I noticed the error in the water tariff, which erroneously stated that 10,000 gallons of water was included for all meter sizes. I called Mr. Harrison to let him know of the error. At 11:24 a.m. that same day Mr. Harrison emailed Ethan Blanchard, at the PUC, requesting that the tariff be corrected. Mr. Blanchard corrected the tariff and sent it back to Mr. Harrison at 12:07 p.m. Mr. Harrison forwarded it to me shortly thereafter at 12:08 pm. (See Attachment A-email string and corrected water tariff). I reviewed the corrected tariff and responded back to him at 5:32 p.m. that the correction looked good and asked him if language for pass-through could be added since this CCN would be in a county that had a groundwater conservation district pass—through fee.

On December 13, 2022, Mr. Harrison sent me a new copy of the tariff that included the pass-through language (see Attachment B).

On December 14, 2022 at 5:32 pm I responded to Mr. Harrison's email indicating that everything looked correct and that I would be filing the consent form, to which he responded "Sounds good, thank you." (see Attachment C for complete email string). I filed the completed consent form into the PUC e-filer at 5:35 pm and received an automated response back from PUC that my filing had been received.

At that point, it was my understanding that what Mr. Harrison and I had agreed upon, with regard to the tariff, would be the final approved tariff. It wasn't until recently, when a customer was questioning rates, that it was discovered that the tariff that contained the error and that did not contain the pass-through language is what was approved at the end of the process.

Based on the fact that the error had been brought to the PUC's attention in the beginning of the consent process and was corrected, and that it was never the intention from the beginning of the application process to include any gallonage in the base rate, Gideon Water LLC is requesting reconsideration and correction of the official tariff to reflect what was in the original submittal and what was sent for approval from PUC staff on December 14, 2022.

If, in the opinion of the ALJ, the final approval of the docket cannot be reconsidered, Gideon Water, LLC requests that the change be made in accordance with TWC 13.244 (e)(1) to correct a clerical or typographical error.

**PURCHASED WATER AND/OR DISTRICT FEE PASS-THROUGH CLAUSE:**

Changes in fees imposed by any non-affiliated third party water supplier or underground water district having jurisdiction over the Utility shall be passed through as an adjustment to the water gallonage charge according to the following formula:

$$AG = G / (1 - L)$$

Where:

AG = adjusted gallonage charge, rounded to the nearest one cent  
G = current purchased water/district approved gallonage charge (per 1,000 gallons)  
L = system average line loss for the preceding 12 months not to exceed 0.15

To implement or modify the pass-through provision, the utility must comply with all notice and other requirements of 16 TAC § 24.25(h).
