**RULE 11 AGREEMENT ON COMMISSION STAFF'S FIRST REQUEST FOR
INFORMATION TO MSEC ENTERPRISES, INC. QUESTION NOS. STAFF 1-1
THROUGH 1-3**

On August 5, 2024, MSEC Enterprises, Inc. (MSEC) filed an application for a pass-through rate change for water Certificate of Convenience and Necessity No. 12887 related to water use fees imposed by San Jacinto River Authority, with a proposed effective date of September 1, 2024.

I. RULE 11 AGREEMENT

On September 9, 2024, the Staff (Staff) of the Public Utility Commission of Texas (Commission) filed Commission Staff's First Request for Information to MSEC Enterprises, Inc. Question Nos. Staff 1-1 Through Staff 1-3 (First RFI). Pursuant to 16 Texas Administrative Code (TAC) § 22.144, the deadline for MSEC to respond to the First RFI is September 30, 2024. Pursuant to 16 TAC § 22.144(k), the parties may modify deadlines for responses, objections, and motions to compel by agreement by filing a letter or other document evidencing the agreement. After further consideration, Staff has determined that MSEC's response to the First RFI is no longer necessary and has decided to withdraw its First RFI. Therefore, Staff and MSEC agree to nullify MSEC's obligation to respond to the First RFI.
