**I. Issues to Be Addressed**

1. Do the proposed amendments to SPS’s existing Interruptible Credit Option (“ICO”) Tariff comport with the requirements of PURA § 36.003?
2. Should the Commission approve SPS’s proposed amendments to its ICO Tariff?
3. Should the Commission approve the customer agreement associated with the ICO Tariff?
4. Do the proposed amendments to SPS’s Secondary General Service (“SG”), Primary General Service (“PG”), and Large General Service – Transmission (“LGST”) tariffs to include an Off-Peak Alternate Rider comport with the requirements of PURA § 36.003?
5. Should the Commission approve SPS’s proposed amendments to its SG, PG, and LGST tariffs to include an Off-Peak Alternate Rider?

6. Should the Commission approve the customer agreement associated with the Off-Peak Alternate Rider?
7. Does SPS's proposed Southwest Power Pool Integrated Marketplace Demand Response Option Tariff ("SPP IM Tariff") comport with the requirements of PURA § 36.003?
8. Should the Commission approve SPS's proposed SPP IM Tariff?
9. Should the Commission approve the customer agreement associated with the SPP IM Tariff?
