JOINT MOTION TO EXTEND PROCEDURAL SCHEDULE

Texas Industrial Energy Consumers (“TIEC”), on behalf of itself and Southwestern Public Service Company (“SPS”), the Alliance of Xcel Municipalities (“AXM”), Golden Spread Electric Cooperative, Inc.
