JOINT MOTION TO EXTEND PROCEDURAL SCHEDULE

Texas Industrial Energy Consumers ("TIEC"), on behalf of itself and Southwestern Public Service Company ("SPS"), the Alliance of Xcel Municipalities ("AXM"), Golden Spread Electric Cooperative, Inc. ("GSEC"), and Commission Staff, files this joint motion to extend the procedural schedule. The parties have agreed to extend the deadline for intervenor direct testimony and statements of position by one week, with corresponding adjustments to the procedural schedule thereafter, except that the hearing on the merits date will remain the same. The parties are requesting this extension in order to provide for more time for settlement discussions. Additionally, given the impending deadline, the parties have agreed to treat the deadline for intervenor direct and statements of position as extended, pending a ruling on the motion.
